



# Cookie Policy

## 1. Information about our use of cookies

- 1.1. This policy explains how we use cookies on the Lancashire Cricket Rewards website (the “**Website**”). We recommend that you read our cookie policy so that you are aware of how we use them and can take steps to reject or delete the cookies if you do not agree to them being used.
- 1.2. Cookies are small text files stored on your device and used by website operators in order to make websites work, or work more efficiently, as well as to provide information to the operators of the website or certain third parties. Each cookie usually contains a unique string of characters, which allows a website to distinguish your browser or device from other users. In this cookie policy, we also use the term “**cookie**” to mean any other similar technology, such as web beacons, local stored objects (such as “**Flash cookies**”), and pixel tags.
- 1.3. We use cookies to enable you to stay logged into your Lancashire Cricket Rewards Account (including the Lancashire Cricket Rewards Points Reminder, if you have downloaded it), navigate between pages and to generally improve your user experience on the Website. We also use cookies to analyse how users find and interact with the Website, to enable us to provide relevant offers to you, and to allow us to identify how our marketing campaigns have performed in general. We also sometimes use cookie type technologies in emails to identify how users come to the Website so that we can evaluate and measure the effectiveness of our email marketing.
- 1.4. We may combine information collected via cookies with information such as your IP address, the type of browser, device and operating system, for example to provide statistical information about visitors to the Website. Where the Website uses third party cookies, you should check with the relevant third party to see how they use cookies (see section 2 below).

## 2. Cookies we use

We use the following cookies on the Website:

2.1. **Strictly necessary cookies** – These are cookies that are required for the operation of the Website.

Points Reminder	PointsReminderCookie	<ul style="list-style-type: none"> <li>This cookie is essential for the Lancashire Cricket Rewards Points Reminder to operate correctly, once you have downloaded the software. When you are logged-in to the Website, you will also be logged-in to the Points Reminder so that you can use the added benefits of the software.</li> </ul>	<p>Once you log-out of your Account</p>

**2.2. Analytical / Performance cookies** – They allow us to recognise and count the number of visitors and to see how visitors move around the Website when they are using it. This helps us to improve the way the Website works, for example, by ensuring that users are finding what they are looking for easily.

2.4. **Targeting cookies** – These cookies record your visit to the Website, the pages you have visited and the links you have followed. We will use this information to make the Website and the advertising displayed on it more relevant to your interests.
